CARE CHECKLIST

- MA Newborn Screening
- Hearing Screening
- CCHD Screening
- Jaundice Screening
- Hepatitis B vaccine
- Birth Certificate

The infant's attending physician may consult the NICU attending, NICU Medical Director, or Well Newborn Care Medical Director to discuss the level of risk for baby, if there is any uncertainty about which scenario is most appropriate for the infant as well as to provide support and assistance.
